

In consideration of my participation in the Gateway Optimist Club fundraiser (describe purpose/event hereafter referred to as the "Event") at Applebee's Neighborhood Grill and Bar in 14091 E lliff Ave (Applebee's Address) on June 14, 2025 I hereby understand and knowingly agree to this release of liability, waiver of legal rights and assumption of risk and to the terms hereof as follows for myself and/or for the participating minor for whom I am the legal parent or guardian:

I take full responsibility for, and I, my heirs, personal representatives or assigns RELEASE AND HOLD HARMLESS and WILL NOT SUE OR MAKE A CLAIM against Applebee's, Inc., Flynn Restaurant Group LP, Apple American Group LLC and their respective subsidiaries, affiliates, successors and assigns, principals, officers, directors, employees, agents and volunteers ("Released Parties"), from any and all liability, claims, demands or causes of actions, as well as loss or damage to my property, that I may hereafter have for injuries or damages arising out of my participation in the Event, including but not limited to, losses, injuries or any harm CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES. I also agree to INDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS from all claims, judgments and costs including attorney's fees, incurred in connection with any action brought as a result of participation in the Event by any of the undersigned. I hereby expressly recognize that this Release of Liability, Waiver of Legal Rights and Assumption of Risk is a contract pursuant to which I have released any and all claims against the Released Parties resulting from any injury, or death, sustained from participation in the Event, including any and all claims for negligence against the Released Parties.

I further represent that I am at least 18 years of age;
